

## CASRA Constitution Revision

- Added Duration of Association Article (II) - perpetual unless dissolved
- Added Affiliations (Article III) - STSR, USSF, FIFA
- Removed Territory (old Article III) (not useful)
- Moved Fiscal Year Definition (old Article IV) to By Laws
- Rewrote Membership (Article V)
  - ▶ Defined Active, Youth, Inactive, Honorary
- Moved Governing Board (old Article VI) to By Laws
- Rewrote Officers (Article VI)
  - ▶ Increased Term to 2 years - 2 consecutive term limit
  - ▶ Modified voting rules to follow Roberts Rules
  - ▶ Removed Officer Attendance requirements (Executive board to handle)
  - ▶ Cleaned up Vacancy, Removals, Resignations
- Rewrote Meetings (Article VII)
  - ▶ Moved meeting details/procedures to By Laws
  - ▶ Added voting quorum definition (increased to 30%)
- Added Dues (Article VIII) - set by By Laws
- Added Ratification (Article IX) - 2/3 majority of all active members
- Rewrote Amendments (Article X) - 2/3 majority of all active members
- Added Dissolution (Article XI) - 2/3 majority of all active members at least 66% present
- Added Miscellaneous Provisions (Article XII)
  - ▶ Clarification of Members association - independent contractors as officials
  - ▶ Added Non-Profit , Tax Exempt information

# By Laws Revision

- Added Membership requirements (101)
  - ▶ Added Membership conduct guidelines
  - ▶ Added Membership judiciary / disciplinary procedures
  - ▶ Added guideline to seek membership of all area assignors
- Changed fiscal year to calendar year (102)
- Added use of CASRA name restrictions (103)
- Defined business procedures, suggested order of business (104)
- Added Government of Association Rules (105)
  - ▶ restated governance by members, quorum
  - ▶ defined funding of association
  - ▶ provided voting rules
- Added Officers / Committees (106)
  - ▶ Moved annual business meeting from April to November (including elections)
  - ▶ Defined 2 year officer terms, starting in January to allow for transition period
  - ▶ Added details concerning Executive Committee / other Committees
- Rewrote Duties of Officers / Committees (107)
  - ▶ Defined presidents voting rules
  - ▶ Added membership retention and recruiting to VP duties
  - ▶ Defined delegation of authority chain
  - ▶ Added Webmaster, Director of Training Appointees of Executive Committee
  - ▶ Added Judicial Committee definition (if one is ever needed)
- Added new section on Meetings (108)
  - ▶ Details on Annual Meeting, monthly meetings, special meetings, openness of ALL meeting minutes/reports
- Added new By Law concerning Training (109)
- Added new By Law to cover Amendments (110)
- Added new By Law to cover Transitions caused by Constitution / By Law changes (111)
